

### Large Brush Collection Guidelines

- · Stack unbound brush in one row that is no more than 4 feet high and 15 feet across.
- · Place brush at least 5 feet away from other objects with the cut ends facing the street.
- Cut trunks 3-8" in diameter to lengths no longer than 6 feet.
- Cut trunks over 8" in diameter to lengths no longer than 3 feet.





BRUSH must be TO THE CURB by 6:30 A.M. on Monday of your collection week. Collections occur Monday through Friday.

### DO NOT:

- Set out items for bulk collection, such as furniture, tires or appliances
- Block sidewalks, mailboxes, or water meters
- Stack or lean brush against a fence, telephone connection box or under low-hanging limbs/wires
- · Place brush in alleys

To help prevent oak wilt, oaks should only be pruned during the hottest summer months and coldest winter months.

Brush collection outside of your scheduled week is available for an additional fee. Call 3-1-1 for pricing. You can also drop off brush for free at Hornsby Bend Biosolids Management Plant, 2210 FM 973 (details at austintexas.gov/brushdropoff).
